



PACKAGE CLEARANCE AND LOGISTICS SERVICES AGREEMENT

This Package Clearance and Logistics Services Agreement ("Agreement") is made and entered into on this ____ day of _____, 20 ("26"), by and between:

JC Grants Logistics and Travel, a company duly organized and operating under the laws of Jamaica, with its principal place of business at **Lot 8 Chandlers Estate, Chateau, May Pen**

Clarendon, hereinafter referred to as the "**Service Provider**";

AND

_____, with its principal place of business at

_____, hereinafter referred to as the "**Partner**."

The Service Provider and the Partner may collectively be referred to as the "**Parties**" and individually as a "**Party**."

1. PURPOSE

The purpose of this Agreement is to establish the terms and conditions under which JC Grants Logistics and Travel shall provide customs clearance, freight handling, transportation coordination, and related logistics services locally and internationally on behalf of the Partner.

2. SERVICES

JC Grants Logistics and Travel agrees to provide the following services on behalf of the Partner:

1. Customs clearance of shipments entering Jamaica.
2. Preparation and submission of customs documentation.
3. Coordination with Jamaica Customs Agency and other relevant government authorities.
4. Payment of duties, taxes, fees, and other charges on behalf of the Partner where authorized.
5. Cargo collection from ports, airports, warehouses, and bonded facilities.
6. Transportation and delivery coordination.
7. Shipment tracking and status updates.
8. Freight forwarding support and logistics consultation.
9. Storage and handling arrangements where applicable.
10. Any additional logistics services mutually agreed upon in writing.

3. APPOINTMENT

The Partner hereby appoints JC Grants Logistics and Travel as its authorized logistics and customs clearance representative for the purpose of carrying out the services described in this Agreement.

JC Grants Logistics and Travel accepts such appointment and agrees to perform the services in a professional and commercially reasonable manner.

4. RESPONSIBILITIES OF THE PARTNER

The Partner agrees to:

1. Provide accurate and complete shipment information.
2. Supply invoices, packing lists, bills of lading, airway bills, permits, licenses, and any other required documentation in a timely manner.
3. Ensure that all goods shipped comply with applicable laws and regulations.
4. Pay all duties, taxes, government fees, freight charges, storage fees, and service charges when due.
5. Promptly notify JC Grants Logistics and Travel of any discrepancies or issues relating to shipments.
6. Cooperate with any customs inspections, audits, or compliance requirements.

5. SERVICE FEES

The Partner agrees to pay JC Grants Logistics and Travel for services rendered in accordance with the fee schedule attached as **Appendix A** or as otherwise agreed in writing.

Additional charges may apply for:

- Customs duties and taxes.
- Port and airport charges.
- Storage fees.
- Demurrage charges.
- Inspection fees.
- Special handling requirements.
- Emergency or expedited services.
- Third-party service provider fees.

6. PAYMENT TERMS

1. All invoices are due within 5 days of the invoice date unless otherwise agreed in writing.
2. JC Grants Logistics and Travel may require advance payment before undertaking customs clearance activities.
3. Late payments may attract interest at the rate of ____% per month or the maximum rate permitted by law.
4. JC Grants Logistics and Travel reserves the right to suspend services for overdue accounts.

7. LIABILITY

JC Grants Logistics and Travel shall exercise reasonable care in performing its obligations under this Agreement.

However, JC Grants Logistics and Travel shall not be liable for:

- Delays caused by customs authorities.
- Government actions or regulatory changes.
- Force majeure events.
- Inaccurate information supplied by the Partner.
- Delays caused by shipping lines, airlines, freight carriers, warehouses, or third parties.
- Losses resulting from prohibited, restricted, or improperly declared goods.

The liability of JC Grants Logistics and Travel shall be limited to the amount of service fees paid by the Partner for the specific shipment giving rise to the claim.

8. INDEMNIFICATION

The Partner agrees to indemnify and hold harmless JC Grants Logistics and Travel, its directors, officers, employees, and agents from any claims, losses, penalties, damages, costs, or expenses arising from:

1. False, inaccurate, or misleading shipment information.
2. Violation of customs or trade laws by the Partner.
3. Improperly declared goods.
4. Breach of this Agreement by the Partner.

9. CONFIDENTIALITY

Both Parties agree to maintain the confidentiality of all business information, customer information, shipment data, pricing information, and proprietary information obtained during the course of this Agreement.

This obligation shall survive termination of this Agreement.

10. TERM AND TERMINATION

This Agreement shall commence on the Effective Date and shall remain in force until terminated by either Party.

Either Party may terminate this Agreement by providing thirty (30) days' written notice to the other Party.

Either Party may terminate this Agreement immediately in the event of:

- Material breach of this Agreement.
- Fraud or misrepresentation.
- Insolvency or bankruptcy.
- Illegal activities involving shipments or business operations.

Termination shall not relieve either Party of obligations accrued prior to the termination date.

11. INDEPENDENT CONTRACTOR

JC Grants Logistics and Travel is acting solely as an independent contractor and nothing in this Agreement shall create a partnership, joint venture, agency relationship, or employer-employee relationship between the Parties.

12. DISPUTE RESOLUTION

Any dispute arising from this Agreement shall first be resolved through good-faith negotiations between the Parties.

If a resolution cannot be reached, the Parties agree to submit the dispute to mediation in Jamaica before pursuing legal proceedings.

13. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of Jamaica.

14. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the Parties and supersedes all prior discussions, negotiations, representations, and understandings relating to the subject matter herein.
